Greetings,

In 2016 there were 33,000 children in Florida reported missing or abducted. Many of Florida's long term missing include some we know may never return home to their loved ones. The Board of Directors of the Florida Missing Children's Day Foundation, Inc. (FMCDF) in support of the Florida Department of Law Enforcement's (FDLE) Missing and Endangered Persons Information Clearinghouse Advisory Board (MEPICAB), would like to take this opportunity to ask for your help in making the 2017 Florida Missing Children's Day a success. The event is held the second Monday every September and is scheduled for Monday, September 11, 2017 at the Capitol in Tallahassee.

Florida's Missing Children's Day is a day about recognition, remembrance and inspiration. Our state government and law enforcement leaders, victim families, school children and members of the public all unite in paying tribute to these children during a most touching ceremony at our Capitol. Our Missing Children's Day this year falls on September 11th, which will mark (or commemorate) the anniversaries of the abduction and murder of 9-year old Jimmy Ryce on 9/11/1995 in Redland, FL; 7-year old Amanda Brown on 9/11/1998 in Tampa, FL; and the disappearance under suspicious circumstances of 8-year old Zachary Bernhardt on 9/11/2000 in Clearwater, FL.

The event adds a network of support to the victim families as they are able to share their stories of heartbreak and hope with others going through similar circumstances during a victim family reception, breakfast with sponsors, the FMCD formal ceremony including the emotional Time of Remembrance, followed by a luncheon.

The occasion is used to salute Florida's heroes, some of which include: exceptional first responders and law enforcement members who work these cases; individuals who have made a difference through their words and actions, often without regard for themselves, to protect a child; those who bring child predators to justice; and, most heartwarming of all, children who acted heroically in the face of being abducted. We champion these heroes and are honored by their presence. Prior to the FMCD formal ceremony, a child identification/safety fair is held in which children are fingerprinted, photographed and provided with child safety materials for both themselves and their parents. Attendees get to meet many of the canine tracking teams that are on hand for the day.

The Foundation was established to financially assist with this annual event through the generous donations of law enforcement, individuals, businesses, and organizations. The Foundation is a statutorily created direct-support organization for FDLE and is a non-profit 501(c)(3) organization. The Foundation Board hopes you or your business will become a sponsor this year.
